- 1. Missouri-American Water Company ("MAWC") filed its *Application and Motion for Waivers* ("Application") on May 26, 2019, requesting Certificates of Convenience and Necessity authorizing it to own and operate water and sewer systems at a development known as the Isla del Sol Condominiums, in Miller County, Missouri.
- 2. On this same day, MAWC filed a *Motion to Consolidate* the water and sewer matters, pursuant to Commission Rule 4 CSR 240-2.110(3), because the actions involve "common questions of law or fact."
- 3. On May 29, the Commission issued an order requesting Staff suggest a deadline to file its recommendation on MAWC's Application and Motion to Consolidate by June 19, 2019.
 - 4. Staff suggests a deadline of August 16, 2019 to file its recommendation.

5. Staff does not oppose MAWC's Motion to Consolidate. Staff requests that the water case be the lead case.

WHEREFORE, Staff respectfully submits this Staft's Suggested Deadline for Recommendation and Nonopposition to Motion to Consolidate, suggesting a deadline of August 16, 2019 to file its recommendation and nonopposing MAWC's motion to consolidate.
