ORDER DIRECTING STAFF'S RECOMMENDATION

On December 8, 2021, the Commission issued its *Order Approving Stipulation and Agreement, Asset Transfer, and Certificates of Convenience and Necessity*, which became effective on December 18, 2021. The Order required Liberty Utilities (Missouri Water) LLC d/b/a Liberty Utilities (Liberty) to submit tariff sheets updating its EFIS tariffs P.S.C. MO No. 14 and 15, applicable to water service and sewer service in its Bolivar service area. On December 31, 2021, Liberty filed a Tariff Revision under Tracking No. YW-2022-0195 (Tariff Sheet). The effective date of the Tariff Sheet is February 1, 2022. The Commission will order the Staff to file a recommendation.

THE COMMISSION ORDERS THAT:

1. The Staff shall file a recommendation on the tariff submitted by Liberty Utilities under Tracking No. YW-2022-0195¹ no later than January 18, 2022.
2. This order shall be effective when issued.
