## ORDER DIRECTING FILING OF A STATUS REPORT

On June 29, 2022, the Commission issued an *Amended Report and Order* in this matter, effective July 9, 2022. In that order, the Commission granted Certificates of Convenience and Necessity to Missouri-American Water Company (MAWC) subject to sixteen (16) conditions, enumerated in ordered paragraph 3.

The Commission will direct its Staff to provide a status report on whether MAWC has complied with the conditions and whether this file may be closed. The Commission will also give MAWC an opportunity to respond to Staff's status report.

### THE COMMISSION ORDERS THAT:

1. No later than January 19, 2023, Staff shall file a report on the status of MAWC's compliance with the conditions listed in ordered paragraph 3 of the *Amended Report and Order* issued by the Commission in this matter. Staff shall also advise the Commission on whether this file may be closed.
2. MAWC shall have until January 30, 2023, to file any response to Staff's status report.
3. This order shall be effective when issued.
