## STAFF RECOMMENDATION REGARDING PROPOSED COMPLIANCE TARIFF SHEETS

)

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff), through counsel, and states the following regarding the proposed compliance tariff sheets Missouri-American Water Company (MAWC) filed, bearing effective dates of October 6, 2022.

1. On July 21, 2022, the Commission issued its *Order Approving Transfer of Assets and Granting Certificate of Convenience and Necessity* (Order), which granted MAWC a certificate of convenience and necessity to provide water and sewer service in Monsees Lake Estates Subdivision in Pettis County, Missouri.

2. On September 6, 2022, MAWC filed proposed tariffs sheets for the water and sewer assets, bearing effective dates of October 6, 2022. The tariff sheets were assigned tariff tracking numbers YW-2023-0050 and YS-2022-0051.

3. On September 8, 2022, MAWC filed three proposed substitute tariff sheets, also bearing effective dates of October 6, 2022, to correct issues with the sheets filed September 6. The substitute tariff sheets are the area maps for the water and sewer service territories and the water schedule of rates.

4. On September 12, 2022, the Commission ordered Staff to file a

recommendation by September 19, 2022 regarding MAWC's proposed tariff sheets.

5. Staff reviewed MAWC's proposed tariff sheets and determined that the

following comply with the Commission's Order and recommends approval:
