ORDER DIRECTING EXPEDITED RECOMMENDATION ON TARIFFS

Effective Date: December 12, 2022

On December 8, 2022, the Commission issued an *Order Approving Acquisition of Assets and Granting Certificate of Convenience and Necessity*, effective December 18, 2022. Among other things, that order directed Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) to submit tariff sheets applicable to the water service and sewer service in the requested service area in P.S.C. MO No. 12 (water) and 13 (sewer), to become effective before closing on the assets.

On December 9, 2022, Confluence Rivers filed new tariff sheets purporting to be in compliance with the terms of the Commission's December 8th order. The new tariff sheets carry a 30-day effective date of January 8, 2023. In addition, Confluence Rivers filed a *Motion for Expedited Treatment* in which it seeks a Commission order approving the proposed tariff sheets to go into effect on December 27, 2022, which would give interested parties less than 30 days' notice to respond to the order.

The Commission will ask its Staff to file a recommendation advising the Commission as to whether the submitted tariff sheets comply with the Commission's December 8th order. In order to attempt to accommodate Confluence Rivers' request for expedited treatment, the Commission will ask for an expedited Staff recommendation.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation regarding Confluence Rivers' new tariff sheets (Tariff Nos. YW-2023-0106 and YS-2023-0107) – or a request for additional time – no later than December 13, 2022.
2. This order shall be effective when issued.
