COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), through counsel, and states the following regarding the proposed compliance tariff sheets Missouri-American Water Company ("MAWC") filed, bearing effective dates of July 14, 2023.

1. On June 7, 2023, the Commission issued its Order Approving Transfer of

Assets and Granting Certificate of Convenience and Necessity ("Order"), which granted

MAWC a certificate of convenience and necessity to provide water and sewer service in Wood Heights, Missouri.

2. On June 14, 2023, MAWC filed proposed tariffs sheets for the water and sewer assets, bearing effective dates of July 14, 2023. The tariff sheets were assigned tariff tracking numbers YW-2023-0218 and YS-2022-0219.

3. On June 15, 2023, the Commission ordered Staff to file a recommendation by June 26, 2023 regarding MAWC's proposed tariff sheets.

4. Staff reviewed MAWC's proposed tariff sheets and determined that the following comply with the Commission's Order and recommends approval:
