On June 22, 2023, Missouri-American Water Company (MAWC) filed the above-referenced applications. The applications seek, among other things, authority for MAWC to acquire and operate the water and sewer systems of The City of Ironton.

The Commission ordered its Staff to file a Recommendation or a Status Report no later than August 11, 2023. On August 4, 2023, Staff filed a Status Report in which it stated it could file a Recommendation no later than October 12, 2023. Thus, the Commission will order its Staff to file a Recommendation on that date.
