## **CLARIFICATION OF WAIVERS**

COMES NOW the Staff (Staff) of the Missouri Public Service Commission (Commission) and for its clarification of waivers in this matter respectfully states:

- 1. On September 1, 2000, K-Powernet, L.L.C. (K-Powernet), filed an application for a certificate of service authority to provide interexchange and nonswitched local telecommunications services within the State of Missouri.
- 2. On September 13, 2000, K-Powernet filed an amended application and substitute tariff sheets in which it revised the requested list of waivers. On October 2, 2000, the Commission granted K-Powernet leave to amend its application.
- 3. On September 20, 2000, the Staff filed a Staff Recommendation in which it recommended that the Commission approve the waivers listed in the Notice of Applications. In its Staff Recommendation, Staff did not specify which waivers listed in the Notice of Applications it recommends the Commission approve.
- 4. On October 3, 2000, the Commission issued an Order Directing Filing in which it requested that Staff clarify which waivers it recommends the Commission approve.
- 5. Staff clarifies its September 20, 2000, Staff Recommendation by stating that the waivers for which it is recommending approval are those waivers listed on the cover page of the



Notice of Applications under the heading Waivers for Interexchange & Nonswitched Local Exchange Carriers. These waivers are identical to the waivers requested by K-Powernet in both its amended application and its substitute tariff sheets.
