AMEREN MISSOURI'S WITHDRAWEL OF MOTION TO RECLASSIFY

COMES NOW Union Electric Company, d/b/a Ameren Missouri ("Ameren Missouri" or the "Company") and in response to the Commission's March 5, 2014 *Order Regarding Requested Waiver of Confidential Information Regulation*, states as follows:

1. On February 24, 2014, Ameren Missouri filed a motion seeking a Commission order reclassifying information Noranda had designated as "highly confidential" to "proprietary."
2. On February 28, 2014, Noranda responded to Ameren Missouri's motion, indicating that it had no objection to Ameren Missouri providing such information to employees of Ameren Missouri and its affiliates, and requested that the Commission grant a waiver of 4 CSR 240-2.135 to allow Ameren Missouri to treat the information as "proprietary" even though Noranda had classified it as "highly confidential." Noranda's response further indicated that if the Commission granted the waiver Ameren Missouri would withdraw its motion to reclassify.
3. Given that the Commission has granted the requested waiver, Ameren Missouri hereby withdraws its February 24, 2014 motion to reclassify, with the understanding that Ameren Missouri does not waive its right to challenge confidentiality designations Noranda may give to information filed or produced in this case.
