any application to intervene must be filed no later than July 10, 2006. (4-CSR-240-2.050, 4-CSR 240-2.075). Any requests for hearing shall also be filed by that date. The Commission Staff shall also file its recommendation or preliminary response as directed below.

- 3. Frimel Water System, Inc. and Lake Lorraine Property Owners' Association shall immediately send notice of this application to the customers of Frimel Water System, Inc., and shall file a copy of that notice in this case.
