**ORDER DIRECTING NOTICE, ADDING PARTY, AND
SETTING DATE FOR SUBMISSION OF INTERVENTION REQUESTS**

On February 11, 2010, Bear Creek Water and Sewer, LLC ("Bear Creek"), filed an application. That application requests, among other things, authority from the Commission for Bear Creek to sell its sewer system and its certificate of convenience and necessity to Table Rock Lake Community Service, Inc., ("Table Rock Lake Community Service").

Because Table Rock Lake Community Service wants a certificate of convenience and necessity, the Commission will add it as a party to this case. The Commission reminds Table Rock Lake Community Service that as a corporation, it must obtain legal counsel to represent its interests before the Commission.

The Commission finds that notice of this application should be given to the general public and interested parties and a date for intervention of proper parties should be set. The Commission's Data Center shall mail a copy of this notice to the County Commission of Taney County, and to the Department of Natural Resources of the State of Missouri. In addition, the Commission's public information officer shall make notice of this order available to the media serving Taney County and to the members of the General Assembly representing Taney County.

The requirement of a hearing has been fulfilled when all those having a desire to be heard are offered an opportunity to be heard. If no proper party or governmental entity is granted intervention and neither the Commission's Staff nor the Office of the Public Counsel requests a hearing, the Commission may determine that a hearing is not necessary.¹

THE COMMISSION ORDERS THAT:

1. Table Rock Lake Community Service, Inc., is added as a party to this case.
2. The Missouri Public Service Commission's Data Center is ordered to serve notice as described in the body of this order.
3. The Missouri Public Service Commission's information officer is ordered to serve notice as described in the body of this order.
4. Any proper person wishing to intervene in this matter shall file an application no later than March 9, 2010. Such applications shall be filed with:
