## **MOTION FOR EXTENSION**

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff") and for its *Motion for Extension*, states as follows:

- 1. On February 6, 2020, Liberty Utilities (Missouri Water) LLC d/b/a Liberty Utilities ("Liberty Water"), filed an *Application* with the Missouri Public Service Commission ("Commission") requesting the Commission approve its acquisition of the water and sewer franchises and assets of Lakeland Heights Water Company, Oakbrier Water Company, R.D. Sewer Company LLC, and Whispering Hills Water System ("Selling Utilities").
- 2. On February 10, 2020, the Commission issued its *Order Directing Notice* and Setting Dates for Submission of Intervention Requests and Staff Recommendation; in its Order, the Commission directed Staff to file, no later than March 26, 2020, a recommendation regarding Liberty Water's *Application*.
- 3. While Staff has issued a number of data requests in its review, has held discussions with Liberty Water and the Selling Utilities, and has reviewed the books and records of the utilities at issue in this matter, it has yet to finish its review of Liberty Water's *Application*.

4. In addition, due to logistical issues between the parties, Staff has yet to

complete its inspections of the Selling Utilities' systems. Due to the COVID-19 pandemic

and the surrounding uncertainty it has caused, Staff is uncertain as to when it will be able

to complete inspections of the selling systems. As an alternative, Staff is currently

reviewing past inspection reports for the systems to determine if they can be used in

finalizing its Recommendation.

5. To allow additional time for its review, and for potential coordination of

inspections of the systems, Staff requests an extension of sixty (60) days to finalize and

submit its Recommendation in this matter. Notwithstanding this request, Staff will aim to

complete its Recommendation as soon as is practically possible.

WHEREFORE, Staff respectfully submits this Motion for Extension for the

Commission's information and consideration and hereby requests the Commission

approve Staff's request for a sixty (60) extension, and order Staff to file its

Recommendation no later than May 25, 2020.
