On August 9, 2022, the Commission held a procedural conference in this matter at which all parties attended. At that procedural conference, Foxfire Utility Company (Foxfire) and Ozark Clean Water Company (OCWC) indicated they would seek a settlement with the Office of the Public Counsel (OPC) in this matter regarding its opposition, and if no settlement is reached they would file a joint proposed procedural schedule. No parties objected. The Commission memorializes the discussion and will set a deadline for the parties to file either a proposed settlement or pleading indicating that a settlement agreement is in progress, or a proposed procedural schedule.

THE COMMISSION ORDERS THAT:

1. The parties shall file either a proposed settlement or pleading indicating a settlement is in progress, or a proposed procedural schedule, no later than August 19, 2022.
2. This order shall be effective when issued.
