On August 10, 2022,<sup>1</sup> 188 North Summit, LLC and Seges Utility Company, LLC filed a request to transfer ownership and operation of a water and wastewater system in Seges Mobile Home Park, located in Callaway County, Missouri. On November 1, the Staff of the Commission (Staff) filed its recommendation that the Commission approve the transfer request.

The Commission will set a deadline for responses to Staff's recommendation and also set a deadline for hearing requests.

### THE COMMISSION ORDERS THAT:

1. No party is required to respond, but any party that wishes to respond to Staff's recommendation, or request a hearing, shall do so on or before November 14, 2022.

2. This order shall be effective when issued.
