**STAFF’S SUPPORT OF TARIFF SHEETS**

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and for its motion supporting the revised tariffs filed by Algonquin Water Resources of Missouri, LLC d/b/a Liberty Utilities, formerly known as Algonquin Water Resources of Missouri, LLC d/b/a Liberty Water, respectfully states to the Missouri Public Service Commission (Commission) the following:

1. On June 1, 2012, Algonquin Water Resources of Missouri, LLC d/b/a Liberty Utilities filed with the Commission six adoption notices and six revised tariff title sheets for Algonquin Water Resources of Missouri, LLC d/b/a Liberty Utilities, formerly Algonquin Water Resources of Missouri, LLC d/b/a Liberty Water. Included among these tariff filings, the Company filed the following tariff sheets, Tariff File Nos. YW-2012-0777, YW-2012-0778, YW-2012-0779, YW-2012-0780.

2. On June 4, 2012, the Commission issued an *Order Directing Filing* directing Staff to file its recommendation no later than June 21, 2012. This filing complies with that Order.




