**STAFF’S COMPLIANCE TARIFF RECOMMENDATION**

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and in this matter hereby submits *Staff’s Compliance Tariff Recommendation*:

1. On October 9, 2019, the Commission issued its *Report and Order* in the above-styled case. The *Report and Order* directed Carl Mills to submit a complete tariff for water service as a 30-day filing within ten days after the effective date of the *Report and Order*. The *Report and Order* had an effective date of November 8, 2019.

2. On November 15, 2019, Mr. Mills filed tariff sheets as ordered by the Commission (“Original Sheets”). The Original Sheets show an effective date of December 18, 2019, but had no issue date.

3. On November 19, 2019, the Commission issued its *Order for Staff to File a Pleading*, ordering Staff to file a pleading no later than December 3, 2019, regarding whether Tariff No. YW-2020-0078 complies with the Commission’s *Report and Order*.

4. On November 21, 2019, Mr. Mills filed substitute tariff sheets (“Substitute Sheets”) showing an issue date of November 15, 2019.

5. After review, Staff concludes that the filings comply with the Commission’s *Report and Order*. Thus, Staff recommends approval of:


