**COMES NOW** the Staff of the Missouri Public Service Commission (Staff) and for its *Status Report*, states as follows:

- 1. On May 26, 2019, Missouri-American Water Company (MAWC or Applicant) filed an *Application* requesting a Certificate of Convenience and Necessity authorizing MAWC to install, own, acquire, construct, operate, control, manage and maintain a water system and a sewer system in an area of Camden County, Missouri; MAWC's *Application* also requested a waiver of the notice requirement contained in Rule 4 CSR 240-4.017(1). Additionally, MAWC filed a Motion to Consolidate on May 26, 2019.
- 2. On May 29, 2019, the Commission issued an *Order Directing Notice*, Setting Date for Intervention, and Order Directing Staff Recommendation; in its Order, the Commission directed Staff to file, no later than June 19, a statement indicating when Staff will be able to file a recommendation on the *Application* and on the *Motion to Consolidate*.
- 3. Staff does not oppose the *Motion to Consolidate* and does not oppose File No. WA-2019-0366 being the lead case.

4. At this time Staff anticipates filing its recommendation in this matter no later than August 16, 2019.

**WHEREFORE**, Staff respectfully submits this *Status Report* for the Commission's information and consideration and hereby requests the Commission approve Staff's anticipated August 16, 2019, date for filing its recommendation in this matter.
