On November 2, 2017, Confluence Rivers Utility Operating Company, Inc., (“Confluence Rivers”) filed applications seeking, among other things, authority for Confluence Rivers to buy the assets of twelve water and sewer companies, and to then provide water and sewer service to the customers of those companies. Staff filed its Recommendation on March 6, 2018. The Office of the Public Counsel (“OPC”) responded on March 15, 2018, and Confluence Rivers responded on March 16, 2018.

The Commission will order responses to OPC’s March 15, 2018 pleading, and will allow responses to Confluence Rivers’ March 16, 2018 pleading.

THE COMMISSION ORDERS THAT:

1. The parties shall respond to OPC’s March 15, 2018 pleading, and may respond to Confluence Rivers’ March 16, 2018 pleading no later than March 30, 2018.

2. This order shall be effective when issued.


