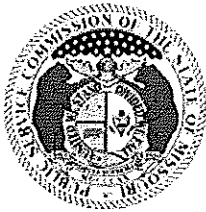
On March 29, 2018, Lake Perry Lot Owners' Association ("The Association") filed an application to intervene. The Association claims it has an interest different from that of the general public as it represents the lot owners to whom Port Perry Service Company provides service. Port Perry is a company Confluence Rivers wishes to acquire.

Commission Rule 4 CSR 240-2.080(13) allows parties ten days to respond to pleadings unless otherwise ordered by the Commission. The Commission issued no order to the contrary of the rule, more than ten days have elapsed since the application to intervene, and the Commission received no responses.

Commission Rule 4 CSR 240-2.075(4) allows the Commission to grant intervention to a person who has an interest different from that of the general public and which may be adversely affected by a final order arising from the case, or if granting intervention would serve the public interest. Upon review of the unopposed application, the Commission finds that The Association meet the standard in Commission Rule 4 CSR 240-2.075(4). Therefore, the Commission will grant the application to intervene.

THE COMMISSION ORDERS THAT:

1. The Application to Intervene filed by Lake Perry Lot Owners' Association is granted.
2. This order shall be effective when issued.




