THE COMMISSION ORDERS THAT:

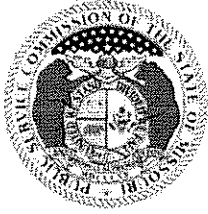

This case is set for a hearing on the record at the Governor’s Office Building, Room 310, 200 Madison Street, Jefferson City, Missouri, commencing at 10:00 a.m., January 24, 2019, for a hearing on the record to determine whether the Missouri Public Service Commission (“Commission”) should approve the Unanimous Stipulation and Agreement.³ The parties shall appear prepared to present such argument and/or evidence and make such record as is necessary for the Commission to make this determination.




