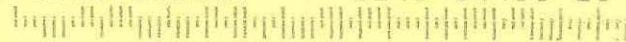

**ORDER AMENDING PROCEDURAL SCHEDULE  
AND REQUIRING STATUS REPORT**

Effective Date: December 10, 2018

On October 17, 2018, the Public Service Commission of the State of Missouri (“Commission”) issued an *Order Adopting Procedural Schedule*.<sup>2</sup> On December 4, 2018, the Commission issued its *Notice and Order Regarding Public Hearings and Procedural Schedule*, requiring the parties to confer and, no later than December 10, to file recommendations, including any proposed amendments regarding the public hearing and procedural schedule. On December 5, 2018, the Commission issued an *Amendment to Order Requiring Lake Perry to Reply and Staff to File Recommendation*. This Order required Lake Perry Lot Owners’ Association (“Intervenor”) to file a reply to a response filed by Confluence Rivers Utility Operating Company, Inc., to Intervenor’s *Motion to Compel Answers to Certain Data Requests*. Intervenor was ordered to file that reply no later than December 10, 2018.

On December 7, 2018, the Company, on behalf of itself, the Staff of the Commission (“Staff”), the Office of the Public Counsel (“OPC”), and the Intervenor, filed a *Status Report*

and Motion for Modification of Procedural Schedule ("Motion"). The Motion asks that certain deadlines be set back in connection with ongoing settlement discussions. The Commission will sustain the Motion. As a part of this order, the Commission will set a date for the parties to file recommendations regarding a procedural schedule. The Commission cautions, however, that except as herein amended or as otherwise ordered in the future, the present procedural schedule shall remain in full force and effect.

**THE COMMISSION ORDERS THAT:**

1. The Procedural Schedule is amended so that no later than the dates stated below, the indicated actions shall be completed:

December 14, 2018	Filing of Stipulation and Agreement or a Status Report <sup>3</sup>
December 18, 2018	Filing of Recommendations Regarding Public Hearing and Procedural Schedule
December 18, 2018	Filing of Reply and Recommendations concerning Intervenor's Pending Motion to Compel
January 3, 2019	Filing of Rebuttal Testimony
January 22, 2019	Filing of List of Issues
January 25, 2019	Filing of Statements of Position

2. In all other respects, the current Procedural Schedule shall remain in effect.<sup>4</sup>
3. This Order shall be effective when issued.


