THIRD ORDER EXTENDING THE DUE DATE FOR STAFF'S RECOMMENDATION

On April 11, 2022, the Commission extended the date for the Commission's Staff (Staff) to file its recommendation from April 11, 2022, to July 11, 2022, at Staff's request. The Commission later extended the due date for Staff's recommendation to August 11, 2022, at the request of Carl R. Mills and Carriage Oaks Estates Water and Sewer Not-for-Profit Corporation.

On August 2, 2022, Staff filed a motion asking that the Commission again delay the time for it to file its recommendation to August 25, 2022, to allow for the filing of an amended application.

The Commission will grant the motion and delay the due date for Staff's recommendation.

THE COMMISSION ORDERS THAT:

1. The due date for Staff's recommendation in this matter is extended to August 25, 2022.
2. Any responses to Staff's recommendation or Carl Mills' application shall be filed no later than September 7, 2022.
