MAWC'S MOTION FOR EXTENSION

COMES NOW Missouri-American Water Company ("MAWC" or "Company"), by and through the undersigned counsel, and, as its *Motion for Extension*, states as follows to the Missouri Public Service Commission ("Commission"):

- 1. On June 29, 2022 (effective July 9, 2022), the Commission issued its *Amended Report and Order* in this matter.
 - 2. Among other things, "Ordered" paragraph 3.f. (p. 35) stated as follows:

MAWC shall develop a plan to book all of the Eureka plant assets, with the concurrence of Staff and/or with the assistance of Staff, for original cost, depreciation reserve, and contributions (CIAC) for appropriate plant accounts, along with reasonable and prudent transaction, closing, and transition costs. This plan should be submitted to Staff for review within sixty (60) days after closing on the assets.

- 3. MAWC closed on the Eureka assets on August 4, 2022. Subsequently, on September 30, 2022, MAWC provided notice that it had completed the Customer Experience Department/Billing conditions found in Ordered paragraphs 3.i, 3.l, 3.m, 3.n, and 3.o.
- 4. MAWC has not yet completed the compilation of the information required to provide for Staff's review a plan to book the Eureka plant assets, primarily due to the quantity of assets involved. Accordingly, MAWC hereby moves for a thirty (30) day extension of the Ordered paragraph 3.f condition, or until November 2, 2022.

5. Counsel for MAWC has discussed this matter with counsel for the Staff of the Commission who indicated that Staff has no objection to the extension requested herein.

WHEREFORE, Missouri-American Water Company requests that the Commission grant this *Motion for Extension* and extend the date for submission to Staff for review of a plan to book all of the Eureka plant assets for thirty (30) days, or until November 2, 2022.
