On April 11, 2022, Staff of the Commission filed a request to reopen the record. Staff acknowledges that under Commission rules the request is not timely after the filing of briefs.<sup>1</sup> However, Staff argues there is good cause to waive the Commission rule and reopen the record to take additional evidence related to assessments being paid by City of Eureka residents. Staff also requested that the Commission set a procedural conference. The Commission will shorten the time for parties to file responses to Staff's motion.
