**ORDER DIRECTING NOTICE, SETTING AN INTERVENTION  
DEADLINE, DIRECTING STAFF TO FILE A PLEADING, AND SETTING  
TIME FOR RESPONSES TO MOTION TO CONSOLIDATE**

On April 21, 2022, Missouri-American Water Company (MAWC) filed applications requesting the Commission grant MAWC Certificates of Convenience and Necessity (CCN) to acquire, own, install, construct, operate, control, manage and maintain water and sewer systems in Jasper County, Missouri. The requested CCN would allow MAWC to acquire the water and sewer assets of the City of Purcell. The application also requests a variance of the 60-day notice requirement contained in Commission Rule 20 CSR 4240-4.017(1), and a request for expedited treatment of its applications.

MAWC also filed a motion to consolidate the water and sewer CCN applications.

The Commission will direct that notice be given, set a deadline for intervention requests, order its Staff to file a pleading, and set a time for responses to MAWC’s motion to consolidate.

**THE COMMISSION ORDERS THAT:**

1. The Commission's Data Center shall provide a copy of this order to the County Commission of Jasper County, Missouri, and the General Counsel for the Missouri Department of Natural Resources.
2. The Commission's Public Policy and Outreach Division shall make notice of this order available to the members of the General Assembly representing Jasper County, Missouri and to the media serving that area.
3. Any application to intervene shall be filed no later than May 23, 2022.
4. No later than April 29, 2022, the Commission's Staff shall file a pleading indicating when it can file a recommendation regarding MAWC's applications.
5. Any responses to MAWC's request to consolidate the water and sewer CCN applications shall be filed no later than April 29, 2022.
6. This order shall be effective when issued.
