# ORDER GRANTING SECOND EXTENSION OF TIME TO FILE STAFF RECOMMENDATION

On May 10, 2022,<sup>1</sup> Missouri-American Water Company (MAWC) filed an application seeking a certificate of convenience and necessity (CCN), and authority to acquire a water system and sewer system in and around the City of Stewartsville, Missouri (Stewartsville System), located in DeKalb and Clinton Counties. The Staff of the Commission (Staff) was directed to produce a recommendation, or request an extension of time, on or before June 27, which was later extended to September 26.

On September 26, Staff requested an extension of time until October 11, to file its recommendation. In support of its request, Staff stated that MAWC has agreed to the extension request, and that Staff and MAWC have worked together to reach a compromise to revise the requested service area. To complete that work, Staff requested a 15-day extension.

The Commission finds Staff's request to be reasonable and will grant it.
