ORDER GRANTING REQUEST FOR EXTENSION OF TIME

On July 26, 2022, Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed applications that sought permission and approval for certificates of convenience and necessity (CCN) to construct, install, own, operate, maintain, control, and manage a water system and a sewer system, respectively, in an area of Lincoln County, Missouri.

On July 28, 2022, the Commission directed the Staff of the Commission (Staff) to file a recommendation regarding the applications, or a request for additional time, on or before September 12, 2022.

On September 6, 2022, Staff filed a *Request for Extension*, requesting that the deadline to file a recommendation be moved to on or before November 10, 2022.

The Commission finds the request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Staff's request for additional time to file its recommendation is granted. Staff shall file its recommendation on or before November 10, 2022.
2. This Order shall be effective when issued.
