ORDER DIRECTING STAFF TO FILE A RECOMMENDATION

On August 12, 2022, Missouri-American Water Company (MAWC) filed applications seeking authority for MAWC to acquire and operate the assets of a water system and a sewer system in and around the City of Smithton, Missouri. On August 15, the Commission issued an order directing the Staff of the Commission (Staff) to file a recommendation, or a pleading identifying a date by which it can file a recommendation on the applications. On September 16, Staff filed a pleading indicating that it anticipates filing its recommendation no later than November 18.

The Commission will direct Staff to file its recommendation no later than November 18.

THE COMMISSION ORDERS THAT:

1. Staff shall file its recommendation no later than November 18, 2022.
2. This order is effective when issued.
