**ORDER DIRECTING NOTICE, SETTING DATES FOR INTERVENTION  
REQUESTS, AND DIRECTING FILING OF STAFF RECOMMENDATION**

On March 14, 2023, Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed an application seeking authority to acquire all or substantially all of the water and sewer systems of the currently unregulated systems of Four Seasons North MHP, LLC (Four Seasons). Confluence Rivers requests a Certificate of Convenience and Necessity (CCN) to operate the Four Seasons' systems and provide service to the public. Confluence Rivers also requests waiver of the Commission's rule requiring 60 days' notice prior to filing an application.

The Commission will direct that notice be given and set a deadline for intervention requests. The Commission will direct its Staff to file a recommendation with regard to the application.

**THE COMMISSION ORDERS THAT:**

1. The Commission’s Data Center shall provide a copy of this order to the County Commission of Johnson County, Missouri.
2. The Commission’s Public Policy and Outreach Division shall make notice of this order available to the members of the General Assembly representing Johnson County, Missouri and to the media serving Johnson County, Missouri.
3. Any person wishing to intervene in this matter shall file an application to intervene no later than April 12, 2023. The application shall be filed in the Commission’s Electronic Filing and Information System (EFIS) or with the Secretary of the Commission. Comments on the application may also be made in EFIS.
4. No later than May 3, 2023, Staff shall file a recommendation regarding the application or a status report stating when it expects to file a recommendation.
5. This order shall be effective when issued.
