MOTION FOR EXPEDITED TREATMENT

COMES NOW Missouri-American Water Company (MAWC), and, in accordance with Missouri Public Service Commission (Commission) Rule 4 CSR 240-2.080(16), moves the Commission for expedited treatment of MAWC's tariff sheets filed on March 19, 2018:

1. MAWC intends to close the transaction that is the subject of the Commission's

Order Granting Certificate of Convenience and Necessity on April 3, 2018.

2. Concurrently, with the filing of this Motion, MAWC has filed water tariff sheets consistent with the Commission's Order Granting Certificates of Convenience and Necessity and Granting Waiver. These tariff sheets carry proposed effective dates of April 18, 2017 (30 days), and have been assigned tracking number YW-2018-0116. A list of the filed tariff sheets is attached hereto as **Appendix A**.

3. MAWC hereby seeks the Commission's order allowing the proposed tariff sheets to go into effect on less than thirty days notice.

4. A grant of this motion will further the public interest. The subject transaction will be closed on April 3, 2018. As of that date, MAWC will own and operate the subject systems. The subject tariff sheets are intended to clarify the rates, rules and regulations that will

apply to the subject customers on a going-forward basis. Addressing these tariff sheets in an expedited manner will eliminate or reduce any gap that might exist in regard to these subjects.

WHEREFORE, for the foregoing reasons, MAWC respectfully requests the Commission grant this Motion for Expedited Treatment and approve MAWC's proposed tariff sheets (YW-2018-0116) to be effective on April 3, 2018, or as soon thereafter as the Commission has the opportunity to address this matter.
