On July 3, 2018, Confluence Rivers Utility Operating Company, Inc., ("Confluence Rivers") filed a Motion for Leave to Amend Application and Amendment to Application. Confluence Rivers filed the motion and amendment in response to a May 10, 2018 pleading it filed along with the other parties in this case.

Confluence Rivers filed its initial application on November 2, 2017, in which it asked the Commission to approve its application to purchase several small water and sewer companies. The May 10, 2018 amendment adds other small water and sewer companies to the original application.

The Commission finds good cause for the amendment, and will grant Confluence Rivers leave to amend its application. The Commission will further direct notice of the application be given to the county commissions, local newspapers, and members of the General Assembly representing residents of the counties in which the water and sewer assets described in the July 2, 2018 amendment are located. The Commission will also direct notice of the application to the General Counsel for the Missouri Department of Natural Resources, and will further set a deadline for interested parties to intervene.

2. The Commission's Public Information Officer shall make notice of this order available to the members of the General Assembly representing the counties of: Cole, , Franklin, Lincoln, and St. Francois, and to the media serving those counties.

3. Any person wishing to intervene in this matter shall file an application to intervene no later than August 1, 2018. The application shall be filed in the Commission's Electronic Filing and Information System ("EFIS") or with the Secretary of the Commission.

4. This order shall be effective when issued.
