### ORDER GRANTING APPLICATION TO INTERVENE

Issue Date: April 8, 2022 Effective Date: April 8, 2022

On March 15, 2022,<sup>1</sup> Foxfire Utility Company (Foxfire) filed an application seeking Commission authority to sell its water and sewer assets to Ozark Clean Water Company. It also asked to be relieved of its responsibilities as a water and sewer corporation and requested cancelation of its certificates of convenience and necessity and tariff sheets. On March 15, Ozark Clean Water Company (OCWC) filed a timely application to intervene. More than ten days have passed since OCWC applied to intervene and no party has responded to that application.<sup>2</sup>

Commission Rule 20 CSR 4240-2.075(3) provides that the Commission may grant a motion to intervene if it finds that the proposed intervenor has an interest that differs from that of the general public and that may be adversely affected by the final order arising from the case, or if granting the proposed intervention would serve the public interest. The Commission finds that allowing OCWC to participate will serve the public interest. The Commission will grant the application to intervene.
