ORDER DIRECTING STAFF RECOMMENDATION

On March 15, 2022,¹ Foxfire Utility Company (Foxfire) filed an application seeking Commission authority to sell its water and sewer assets to Ozark Clean Water Company. It also asked to be relieved of its responsibilities as a water and sewer corporation and cancelation of its certificates of convenience and necessity and tariff sheets. On March 16, the Commission ordered Staff to file a recommendation regarding the applications, or a status report indicating when it will file its recommendation. On April 8, Staff filed a Status Report proposing to submit its recommendation by June 14.

The Commission will direct the Commission's Staff to file a recommendation no later than June 14.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation in this matter no later than June 14, 2022.
2. This order shall be effective when issued.
