**ORDER RECOGNIZING NAME CHANGE AND
APPROVING ADOPTION OF TARIFF**

On August 15, 2013, Algonquin Water Resources of Missouri, LLC d/b/a Liberty Utilities submitted notice that it will now be operating under the name Liberty Utilities (Missouri Water) LLC d/b/a Liberty Utilities (“Company”). Company requested the Commission recognize its name change and approve its tariff adoption notice and revised tariff title sheets. The Commission Staff filed *Staff’s Support of Tariff Sheets* on September 6, 2013, indicating it supported the revised tariffs filed by Company. Staff did not assert an objection to Company’s name change.

Company registered the name change with the Missouri Secretary of State’s Office. Company is therefore in compliance with the requirements for a certified name change, as found in Commission Rule 4 CSR 240-2.060(5). No entities intervened to oppose the name change and the filed tariff adoption sheets comply with Commission rules.

After reviewing the request and *Staff’s Support of Tariff Sheets*, the Commission will order that the name change shall be recognized and the tariff adoption notice and revised tariff title sheet approved.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes the name change of Algonquin Water Resources of Missouri, LLC d/b/a Liberty Utilities to Liberty Utilities (Missouri Water) LLC d/b/a Liberty Utilities.
2. The Commission approves the tariff adoption notices to become effective September 14, 2013:
