ORDER RECOGNIZING NAME CHANGE

Issue Date: June 22, 2016

Effective Date: July 1, 2016

On June 1, 2016, Rex Deffenderfer Enterprises, Inc. submitted a revised cover page and revised adoption notice for its existing water tariff seeking to apply the fictitious name “RDE Water Company” to its water tariffs and other filings to be made before the Commission. Staff filed a recommendation regarding the proposed name change on June 21, advising the Commission that the notice of name change complies with the Commission’s requirements. Staff recommends the Commission approve the tariff and recognize the name change. No one has opposed the name change.

The Commission has reviewed the notice of name change and Staff’s recommendation and will recognize the name change. Because this action is unopposed and prompt recognition of the name change is appropriate, the Commission will make this order effective in less than thirty days.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes that Rex Deffenderfer Enterprises, Inc. has changed its name to Rex Deffenderfer Enterprises, Inc., d/b/a RDE Water Company.

2. The proposed tariff sheets submitted under Tariff No. YW-2016-0346 by Rex Deffenderfer Enterprises, Inc., d/b/a RDE Water Company are approved, effective on and after July 1, 2016. The specific tariff sheets approved are:

3. Rex Deffenderfer Enterprises, Inc., d/b/a RDE Water Company shall consistently use “RDE Water Company” in any and all future filings with the Commission and communications with customers.

4. This order shall be effective on July 1, 2016.

5. This file shall be closed on July 2, 2016.
