**MAWC'S STATUS REPORT**

**COMES NOW** Missouri-American Water Company (MAWC) and, as its *Status Report*, states as follows to the Missouri Public Service Commission (Commission):

1. On September 27, 2019, the Commission issued its *Order Staying Proceedings*. Among other things, the Order directed that MAWC file a status report upon the resolution of the asset ownership issues or, not later than November 1, 2019, and the first date of each month thereafter.


2. The asset ownership issues have not been resolved as of this date. The litigation involving the Isla del Sol Condominium Association, Inc. and Rockwood Bank (Case No. 19SL-CC04128) remains pending in the St. Louis County Circuit Court. The parties argued a *Motion to Dismiss or, in the Alternative, to Transfer Venue* on October 11, 2019, and proposed orders have been filed by the parties. However, no ruling on those motions has yet been issued according to the case record found on CaseNet.

3. MAWC will file a status report by December 1, 2019, unless the ownership interest is resolved prior to that date.

**WHEREFORE**, MAWC hereby respectfully requests that the Commission consider this

Status report and deem MAWC to have satisfied the *Order Staying Proceedings*.
