MAWC’S NINTH STATUS REPORT

COMES NOW Missouri-American Water Company (MAWC) and, as its *Ninth Status Report*, states as follows to the Missouri Public Service Commission (Commission):

1. The Commission’s *Order Staying Proceedings* issued on September 27, 2019, directed that MAWC file a status report upon the resolution of the asset ownership issues or monthly until resolved. On June 5, 2020, the Commission issued its *Order Amending Status Report Schedule*, wherein it directed that MAWC file status reports every three months, with the next status report due September 1, 2020.

2. The asset ownership issues have not been resolved as of this date. The litigation involving the Isla del Sol Condominium Association, Inc. and Rockwood Bank continues.¹

3. MAWC will file its next status report by December 1, 2020, unless the ownership interest is resolved prior to that date.

WHEREFORE, MAWC hereby respectfully requests that the Commission consider this
