On April 26, 2021,² Missouri-American Water Company (“MAWC”) filed applications requesting Certificates of Convenience and Necessity (“CCNs”) to install, own, acquire, construct, operate, control, manage, and maintain a water system and sewer system in and around the City of Eureka, Missouri. On October 1, the Commission’s Staff (Staff) filed its Recommendation and recommended the Commission either reject MAWC’s applications, or, alternatively, impose specified conditions should the Commission approve the applications. On October 12, MAWC filed its Response to Staff Recommendation and asked the Commission to approve the applications without Staff’s conditions. The Commission will schedule a procedural conference. The conference will be held virtually by WebEx.

THE COMMISSION ORDERS THAT:

1. A procedural conference is scheduled for October 22, 2021, at 9:30 a.m. by WebEx.
