**STAFF’S COMPLIANCE TARIFF RECOMMENDATION**

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff), through counsel, and recommends that the Commission approve the proposed tariff sheets Missouri-American Water Company (MAWC) filed on July 5, 2022 bearing effective dates of August 4, 2022.

1. On June 29, 2022, in its *Amended Report and Order*, the Commission granted MAWC Certificates of Convenience and Necessity to provide water and sewer service in the service areas currently served by the City of Eureka. The Commission also ordered MAWC to file new and revised tariff sheets before closing on the assets.<sup>1</sup>

2. On July 5, 2022 MAWC filed original and revised proposed tariff sheets in tariff tracking numbers YW-2023-0006 and YS-2023-0006, with proposed effective dates of August 4, 2022.

3. On July 19, 2022 the Commission directed Staff to file a recommendation regarding these tariff sheets by July 22, 2022.

4. Staff reviewed all tariff sheets and concluded that they comply with the Commission’s June 29, 2022 order.

5. Therefore, Staff recommends approval of:


