On April 11, 2022, the Staff of the Commission (Staff) filed its *Request to Reopen the Record* to hear evidence regarding The Arbors of Rockwood Community Improvement District (Arbors CID). The *Request* refers to Exhibit 1 – Eureka Ordinance 2394 – filed with the *Request*. The ordinance, in turn, refers to Exhibit A – Amended Petition for Creation of a Community Improvement District – and Exhibit B – the development agreement among the City of Eureka, the Arbors CID, and the developer. In the Exhibit 1 filing, Exhibit A follows the ordinance, but Exhibit B does not.

The Commission will order Staff to file the development agreement.

THE COMMISSION ORDERS THAT:

1. No later than May 3, 2022, Staff shall supplement its *Request to Reopen the Record* by filing the Arbors CID development agreement as Exhibit B of Exhibit 1.
2. This order shall be effective when issued.
