ORDER SETTING TIME FOR RESPONSES

On June 25, 2021, Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed applications with the Commission requesting that the Commission grant it Certificates of Convenience and Necessity to acquire several water and sewer systems in Benton, Clay, Pettis, Platte, and Camden Counties in Missouri. The Commission issued notice and ordered its Staff (Staff) to file a pleading stating when it could file a recommendation about the applications. Staff asked to file its recommendation on October 5, 2021. The Commission granted that request and set a deadline of October 19, 2021 for any responses to Staff's recommendation or Confluence Rivers' applications.

On October 1, 2021, the Staff filed a motion requesting an extension of time to file its recommendation. The Commission granted that request. On November 4, 2021, Staff filed its recommendation. The Commission will now set a deadline for any responses to Staff's recommendation or Confluence Rivers' applications.

THE COMMISSION ORDERS THAT:

1. Any responses to Staff's recommendation or Confluence Rivers' applications shall be filed no later than November 18, 2021.
2. This order is effective when issued.
