ORDER DIRECTING STAFF TO FILE A RECOMMENDATION AND SETTING A TIME FOR RESPONSES

On April 22, 2022, the Commission issued its order giving notice, setting an intervention deadline, and directing its Staff (Staff) to file a pleading indicating when it could file a recommendation. On April 27, 2022, Staff informed the Commission it could file a recommendation by June 28, 2022. Accordingly, the Commission will direct Staff to file a recommendation by that date and set a time for responses.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation regarding Missouri-American Water Company's application no later than June 28, 2022.
2. Any responses to Staff's recommendation or Missouri-American Water Company's application shall be filed no later than July 8, 2022.
3. This order is effective when issued.
