PROPOSED LOCAL PUBLIC HEARING NOTICE AND HEARING DATE

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), by and through counsel, and with the agreement of Missouri-American Water Company ("MAWC") and the Office of Public Counsel ("OPC") (collectively, the "parties"), states as follows:

1. On July 13, 2022, the Commission issued its Order Granting Request to Have a Local Public Hearing. The order directed the parties to file on or before July 20, 2022, either a request for an extension of time or, if possible a joint pleading stating:

a. A proposed date and time of a virtual public hearing along with any other public hearing details, and

b. Proposed language to be sent to customers notifying them of the virtual public hearing, inclusive of proposed language regarding the potential bill impacts of the sale on typical residential and commercial customers.

2. The parties have conferred and agreed that the Commission may issue an order scheduling a virtual local public hearing on Monday, September 12, 2022, to be held via WebEx video and telephone conference beginning at 6:00 p.m.

3. The parties have agreed that the hearing notice may be as set out in the exemplar attached hereto and incorporated herein by reference as Exhibit A. They would suggest that the Commission provide an access code and password for the notice.

4. Caveat: It is the Staff's position that the numbers provided in the notice are accurate as of July 20, 2022, but must be reviewed prior to publication to account for new WISIRA rates that may go into effect.

WHEREFORE, the Staff of the Missouri Public Service Commission, with the agreement of all parties, respectfully requests that the Commission order that a virtual local public hearing be held as described in the premises and more particularly in Exhibit A, attached hereto; and its further order approving the local public hearing notice set out in Exhibit A, attached hereto; and for such other and further orders as the Commission may deem necessary.

NOTICE OF LOCAL PUBLIC HEARING ON MISSOURI AMERICAN WATER COMPANY'S REQUEST FOR AUTHORITY TO PROVIDE WATER AND SEWER SERVICE IN AND ABOUT THE CITY OF STEWARTSVILLE

The Missouri Public Service Commission ("Commission") has scheduled a local public hearing on Monday, September 12, 2022, to be held via WebEx video and telephone conference beginning at 6:00 p.m., to obtain input from the public regarding Missouri American Water Company ("MAWC") and the City of Stewartville's ("City") plan for MAWC to acquire the assets which the City uses to provide water and sewer service, and to become the water and sewer utility for the City. You are encouraged to participate in this local public hearing and express your views.

MAWC requires the Commission's authorization to provide water and sewer service in and about the City. The Commission oversees MAWC's rates and terms of service, but not those of the City. Currently the City has higher water rates and lower sewer rates than MAWC. MAWC Residential and Commercial customers are charged the same rates. Based on currently effective rates, residential and commercial customers using 5,000 and 35,000 gallons, respectively, would see the following impacts to their monthly bills if MAWC becomes their water or sewer provider.

*These are example bills based on the usage listed. Your actual bill will be based on your monthly water usage. While MAWC intends to use its existing rates for Stewartsville customers, it presently has requests before the Commission to change them in Case Nos. WR-2022-0303 (water) and SR-2022-0304 (sewer). MAWC anticipates to have new water and sewer rates by June 1, 2023.

The local public hearing shall be held via WebEx video and telephone conference on September 12, 2022, beginning at 6:00 p.m. A live audio web stream at the Commission's website, www.psc.mo.gov, will provide audio of the question and answer session and hearing. Anyone who does not intend to participate in the question-and-answer session or speak to the Commission during the hearing should listen via the web stream.
