ORDER GRANTING REQUEST FOR EXTENSION

On July 1, 2022, Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed an application for a certificate of convenience and necessity (CCN) for a water system currently served by Tan Tar A State Road, LLC (Tan Tar A), located in Camden County. The Commission directed the Staff of the Commission (Staff) to provide its recommendation on or before August 23, 2022, later extended to October 24, and then November 14.

Staff now requests an extension of time of one week to address issues that have developed during Staff's analysis. Staff requests an extension to file its recommendation until November 21, 2022.

The Commission finds the extension request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Staff's request for an extension of time is granted. Staff shall file its recommendation, or a request for further extension, on or before November 21, 2022.
2. This order shall be effective when issued.
