#### AMENDMENT TO APPLICATION

COMES NOW Confluence Rivers Utility Operating Company, Inc. ("Confluence Rivers"), pursuant to 20 CSR 4240-2.080(18), and, for its Amendment to Application, states as follows to the Missouri Public Service Commission ("Commission"):

On July 1, 2022, Confluence Rivers filed an application that seeks permission and 1. approval for the acquisition of, and a certificate of convenience and necessity to install, own, acquire, construct, operate, control, manage and maintain a water system within the specified areas currently served by Tan Tar A State Road, LLC (Tan Tar A), located in Camden County. Since that filing, Confluence Rivers has recognized a matter included in that Application that it needs to amend.

2. Commission Rule 4 CSR 240-2.080(18) provides, in part, that "Any pleading may be amended within ten (10) days of filing, unless a responsive pleading has already been filed .... ". The date of this filing is within ten days of the filing of the Application in this case and no responsive pleading has been filed. Accordingly, Confluence Rivers hereby amends its Application as described in the following paragraph.

3. Paragraph 19 of the Application discusses Tariffs and Rates. The Application erroneously states that Confluence Rivers proposes to adopt the rates utilized by the unregulated Tan Tar A system. The unregulated Tan Tar A system has no rates for the area in question.

Accordingly, Confluence Rivers amends paragraph 19 of its Application to state as follows (there is no change to the referenced Appendix G):

19. The unregulated Tan Tar A system has no rates in the area that is the subject of this Application. As a result, Confluence Rivers proposes to adopt the rates that are attached hereto as Appendix G and to utilize the rules governing the rendering of service that are currently found in Confluence Rivers' existing Commissionapproved tariffs for water service for the Osage area (PSC Mo No. 24 (Osage)), until such time as the rates and rules are modified according to law.

WHEREFORE, Confluence Rivers respectfully requests that the Commission recognize the amendment to Confluence Rivers' Application described herein.
