**ORDER APPROVING COMPLIANCE TARIFFS**

Issue Date: March 3, 2023

Effective Date: March 19, 2023

On January 19, 2023, the Commission issued an *Order Approving Acquisition of Assets and Granting Certificate of Convenience and Necessity*, effective February 18, 2023. Among other things, that order directed Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) to submit tariff sheets, to become effective before closing on the assets, to include a revised service area map, service area written description, and rates and charges.

On February 17, 2023, Confluence Rivers filed proposed tariff sheets purporting to be in compliance with the terms of the Commission’s January 19<sup>th</sup> order. The proposed tariff sheets carry an effective date of March 19, 2023.

On February 22, 2023, Confluence Rivers filed two substitute tariff sheets to correct minor omissions. The Staff of the Commission (Staff) filed its recommendation that all of the proposed tariff sheets – both those filed on February 17<sup>th</sup> and the substitute sheets filed on February 22<sup>nd</sup> – be approved.

Upon reviewing the pleadings and Staff’s recommendation, the Commission finds Confluence Rivers’ proposed tariff sheets comply with the Commission’s January 19<sup>th</sup>

order and will approve them. So that the tariffs can become effective on March 19, 2023, the Commission finds it reasonable for this order to be effective in less than 30 days.

**THE COMMISSION ORDERS THAT:**

1. The following proposed tariff sheets filed by Confluence Rivers on February 17, 2023, and February 22, 2023, and assigned Tracking No. YW-2023-0154 (water) and Tracking No. YS-2023-0155 (sewer), are approved to become effective on March 19, 2023:
