**ORDER DIRECTING TARIFF RECOMMENDATION**

On January 19, 2023, the Commission issued its *Order Approving Acquisition of Assets and Granting Certificate of Convenience and Necessity* in this matter, effective February 18, 2023. Among other things, that order directed Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) to submit tariff sheets applicable to the water service and sewer service in the requested service area, to become effective before closing on the assets.

On February 17, 2023, Confluence Rivers filed tariff sheets purporting to be in compliance with the terms of the Commission’s January 19<sup>th</sup> order. The new tariff sheets carry an effective date of March 19, 2023.

The Commission will ask its Staff to file a recommendation advising the Commission as to whether the submitted tariff sheets comply with the Commission’s January 19<sup>th</sup> order.

**THE COMMISSION ORDERS THAT:**

1. Staff shall file a recommendation regarding Confluence Rivers' compliance tariff sheets (Tariff Nos. YW-2023-0154 and YS-2023-0155) no later than February 24, 2023.
2. This order shall be effective when issued.
