STAFF’S REQUEST FOR EXTENSION OF TIME**

On March 14, 2023,¹ Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed applications regarding the acquisition of Four Seasons North MHP, LLC (Four Seasons). The Commission directed a recommendation or a request for an extension of time from its Staff (Staff) no later than May 1. Staff has timely filed a request for an extension of time to submit its recommendation.

Staff requested an extension until June 21 due to outstanding data requests and a physical examination of the subject property. Additionally, Staff stated it is currently waiting to receive information from the Missouri Department of Natural Resources.

The Commission will shorten the time for responses to Staff’s request.
