On June 30, 2023, Confluence Rivers Utility Operating Company, Inc. (Confluence) filed the above-referenced applications. The applications seek, among other things, authority for Confluence to acquire and operate the sewer systems of Brussels Valley Estates, Inc., and Mapaville Meadows. Confluence also wishes to acquire and operate the water and sewer systems of Chevron/Sierra Land Company, LLC. Confluence also seeks certificates of convenience and necessity to operate those systems.

The Commission will direct notice of the application be given to the county commission and local media serving residents of Lincoln, Morgan, and Jefferson Counties, Missouri. The Commission will also set a deadline for interested parties to intervene.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide a copy of this order to the County Commissions of Lincoln County, Morgan County, and Jefferson County, Missouri.

2. The Commission's Public Policy and Outreach Division shall make notice of this order available to the media serving Lincoln County, Morgan County, and Jefferson County, Missouri.

3. Any person wishing to intervene in this matter shall file an application to intervene, no later than July 25, 2023. The application shall be filed in the Commission's Electronic Filing and Information System ("EFIS") or with the Secretary of the Commission. Comments on the application can also be made in EFIS.

4. This order shall be effective when issued.
