 - Jay Williams accumulated deferred income taxes, current and deferred income taxes, property tax;
 - Blake Mertens O&M expense, Iatan and Plum Point trackers, prepayments, Riverton long-term maintenance contract;
 - Steve Williams customer growth and expansions, billing adjustments;
 - Jeff Lee pensions/OPEB; and
 - Mark Quan weather normalization.

3. The Parties waive cross examination as to OPC witness Keri Roth (depreciation expense (Riverton 7), rate case expense, vegetation management trackers, Iatan 2/Iatan Common/Plum Point O&M trackers, Riverton 12 O&M tracker, prepayments).

4. The Parties waive cross examination as to the following DE witnesses:

- John Buchanan energy efficiency, low-income weatherization; and
- Jane Lohraff Economic Development Rider, standby service.

5. The Parties request that the Commission admit into evidence all testimony, including exhibits and other attachments thereto, filed herein by each of the witnesses listed in paragraphs one through four above.

6. The Parties further request that the Commission excuse the witnesses listed in paragraphs one through four above from appearing at the evidentiary hearing herein.

the testimony referenced above and excuse the appearance of the above-listed witnesses.
